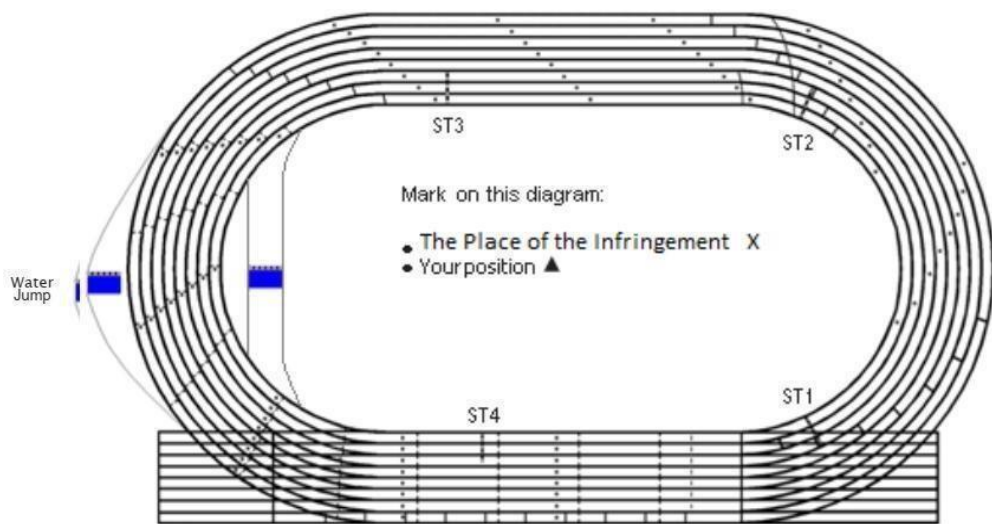

18.1	Obstructed or jostled competitor no ..... so as to impede his/her progress. Advantage gained? Yes / No
18.2(c)	Ran from lane no.... to lane no..... for ...strides (touch/whole foot in inside lane)
18.7	Broke from lane..... for.....strides / metres before the break line
23.5	Athlete in lane no..... who dropped the baton failed to recover it at change .....

Relay - Visually Impaired (T11-12)	
6.14.3	T11 athlete not wearing eye patches and/or opaque glasses and/or eye mask
7.8	Athlete / Guide did not complete race with bona fide effort
7.9	Athlete and Guide not attached by a tether throughout the race
7.10	Athlete pushed / pulled / otherwise propelled by guide in order to gain advantage
19.4	Athlete not in front of Guide when reaching finish line
23.8 (e)	Assistant did not follow instructions of officials at change .....
Wheelchair (T32 – 34 & T51 – 54)	
6.9	Athlete failed to display bib on back of chair or side of running frame.
6.9	Athlete failed to display number on helmet when required under technical regulations.
6.17.3	No helmet worn by athlete
6.18	Athlete allowed urine to drain onto track
14.3	Part of lower extremities(legs and feet) touched the ground during event
18.3	Means other than pushing on the wheels or push rims used to propel chair
18.4	Overtaking athlete cut in before achieving full clearance of chair being overtaken
18.2 (c)	Wheeled from lane.....to lane ..... for ..... pushes/metres (wheel touch/wheel in inside lane)
18.5 (c)	Frame runner wheeled from lane...to lane... for..... steps(wheel touch/ wheel in inside lane)
23.6	Received assistance by pushing or other method during takeover
23.19	4 x 200m / 4 x 400m: Athlete took position other than in the two lanes allocated
Prosthesis (T45- 47 and T61 – 64)	
6.12.1	T61-64 athlete did not complete race with lower limb prosthetic attached
6.12.3	T45-47athlete who competed with upper limb prosthesis did not complete race with device
Assistance to Athletes	
Received assistance or coaching. Give details opposite.	
Athlete Misconduct
