

2025 Australian Athletics Audience Insights Survey – Terms and Conditions

These Terms and Conditions apply to participation in the Audience Insights Survey ("Survey") conducted by **Australian Athletics**. By completing and submitting the Survey, you agree to be bound by the following terms.

1. Eligibility

- 1.1. Entry is open to individuals aged 15 years and over who are residents of Australia.
- 1.2. Employees of Australian Athletics and their immediate families are eligible to complete the survey but are excluded from prize draw participation.
- 1.3. Only one survey response per individual is permitted.

2. Survey Platform

- 2.1. The Survey is hosted and administered via the SurveyMonkey platform.
- 2.2. Participation in the Survey is voluntary. You may choose to exit the Survey at any time prior to submission.

3. Consent to Receive Marketing Communications

- 3.1. By submitting the Survey, you consent to receive marketing and promotional communications from Australian Athletics.
- 3.2. You may opt out of such communications at any time by using the unsubscribe link provided in emails or by contacting Australian Athletics directly.

4. Prize Draw

- 4.1. All eligible participants who complete the Survey in full will be entered into a random prize draw.
- 4.2. The prize is: collection of official Team Australia kit.
- 4.3. The winner will be selected at random and notified via the email address provided in the Survey within seven (7) business days of the survey closing.
- 4.4. If the selected winner does not respond within seven (7) days of notification, Australian Athletics reserves the right to redraw and award the prize to an alternative entrant.
- 4.5. The prize is not transferable, exchangeable or redeemable for cash.

5. Data Collection and Use

- 5.1. The Survey collects personal and demographic information, including but not limited to: age range, gender, location, interests, and engagement behaviours.
- 5.2. Data collected will be used for internal research and strategic planning purposes, including marketing, audience engagement, and commercial development.
- 5.3. Individual responses will remain confidential. Aggregated and anonymised data may be shared with



third-party partners to support audience analysis and reporting.

5.4. No personally identifiable information will be disclosed to external parties without express consent.
